Port dues for ships

Ship fees for port of Södertälje apply from **2025-01-01** until further according to the the International Convention on Tonnage measurement of Ships, 1969.

Standard tariff – ships in service per GT 5,00 kr

Environmentally differentiated charges

In order for a ship to receive a reduced fee for NOx reducing measures, it requires a issued and valid nitrogen oxide reduction certificate issued by the Swedish Maritime Inspectorate. Request for sent to the Traffic Department. Should it be found, during inspection or otherwise, that a ship has breached the conditions laid down by the Swedish Maritime Administration for entitlement to a NOx rebate the ship or its owner/operator is obliged to pay the difference at the full fee for current year.

Environmental discount in the port tariff

Environmental Ship Index (ESI) och Clean Shipping Index (CSI)

LNG: Liquid Natural Gas

The environmental discount is granted on the condition that registration has been carried out in accordance with the provisions of the ESI or the CSI, provided that it is notified in advance Operations Department, Port of Södertälje

Waste fee, sludge

Linesmen

Mooring and unmooring are based on the length of the vessel (loa), with fees for arrival and Departure as below. Linesmen are mandatory as it is a safety issue for the vessel and for the port's control according to the Maritime Security Code, ISPS Code.

Special provisions

Telephone number 08-550 237 62 is a direct line for linesmen services.

Routine according to external linesmen is to call 30 minutes before the service is to be performed.

The master is responsible for ordering (agent or pilot on board can assist if needed).

If an incorrectly ordered boatman results in waiting time costs, the customer will be charged.

Orders for work/overtime work must be made no later than 12.00 noon on the previous working day

Remarks (see also Operating regulations in the Port of Södertälje)

Notification of arriving vessels (Ship Notification) must be submitted in good time, no later than 24 hours before expected arrival of the vessel in the port, in order to enable the planning of the work and the procurement of any extra personnel and machinery.

For waiting time and additional work on board, such as shifting of containers, unhatching, lashing, stamping etc. are charged on an hourly basis.

Strip and stuff - arriving or departing by ship or rail
